Senior Portrait Contract

This contract constitutes an order for senior portraiture services as agreed to by both parties: Finch Fotography (Photographer) and Contracting Party (Client).

Session Fee

The full session fee is required to reserve Client's time and date for services. If Client cancels at least 48 hours in advance of the scheduled session time, a \$75 cancellation fee will be charged and the remaining amount paid will be refunded to Client. No refund is available if canceled less than 48 hours prior to the scheduled session time. If Client needs to reschedule a session, a \$25 rescheduling fee will be charged. In the event that Photographer determines the weather will impede Photographer from providing said services, the session will be rescheduled. In the event that Photographer must cancel the session, effort will be made to reschedule the session. However, Client will be refunded the entire amount paid if the session is not rescheduled when Photographer must cancel.

If Client chooses a Collection Session, Client understands that a Print Collection purchase is required.

Prices & Ordering

Costs of prints/products must be paid in full before they will be processed, printed and delivered. Shipping costs will apply to all orders that are mailed. Client will have **21 days from the time the image gallery is posted online to order products. The gallery will be deleted after 21 days. If Client wants the gallery reposted, a \$50 fee will be paid, the \$50 will be credited toward Client's purchase, and the gallery will available for 21 days. If prices change after the initial 21 days, the prices in effect at the time the gallery is reposted will apply.**

Copyright

Client understands that copying and/or reproducing any images/photographs produced by Photographer, in any form, is prohibited by U.S. copyright laws. All copyrights belong to and remain that of Photographer even if Client purchases the digital files from the session. If the digital files from the session are purchased, permission to make prints/products will be granted to Client and a separate release will be issued to Client upon delivery of goods. Web Files are 600 pixels on the longest side of the image, contain a 719 Seniors logo, and are optimized for emailing and online sharing (MySpace, Facebook, etc.). Web Files are not intended for and may not be used for prints/reproduction and can be used for personal, non-commercial use only.

Model Release

Client agrees that Photographer is granted the right to display and/or use any images/photographs made in conjunction with this session(s) in all forms of reproduction and media to include, but not limited to, advertising, editorial, private, public and electronic displays, web sites, instruction, competition, resale and any other lawful purposes.
